




# **CORPORATE EVOLUTION**

## ***Flexible Membership at Mill Hill Golf Club***

Mill Hill Golf Club now offers flexible corporate membership which has been tailor made to suit any size of business. It is a modern low cost approach to playing golf at a Private Members Club.

The scheme can be used for any number of staff or clients and is purely based on the number of rounds played rather than the number of people using it.

The only restriction being play before 12 noon at weekends, and groups of 6 or more would need prior arrangement via the office/pro shop for weekend play (subject to availability).

### **£1500+ vat allows you 1300 credits that can be exchanged for the following:**



**weekend round before 12pm**

**32 credits**



**weekend round after 12pm**

**22 credits**



**weekday round before 12pm**

**20 credits**



**weekday round after 12pm**

**15 credits**



**Twilight or anytime Monday round**

**12 credits**

**(Twilight rounds start from 12pm Winter and 4pm Summer)**

**You also have the benefit of a 10% discount from the green fee price during any company day should you wish to arrange one.**

The management reserve the right to raise the points per round by a maximum of 10% in any one calendar year.

The bottom line is you or your guests can play up-to a maximum of 108 rounds of golf per year.

## How Does It Work?

Your business will be issued with up to 20 membership cards that are all linked to the same account. On each visit to the golf club the account will be debited with the corresponding number of points.

The membership cards can also be loaded with funds that can be used for bar and catering, effectively giving you the option to send clients on a totally free day out whether you are personally present or not.

## Frequently Asked Questions



### **How do I book a tee time**

Use the online booking system up to 4 days in advance or via phone for group play.



### **Do I need to book a tee time**

Yes you do. You must always book a tee time before play and check in at the pro shop to have the account debited and a ticket issued.



### **Can I play in competitions**

Corporate members are not eligible to play in competitions or club matches but are eligible to play in swindles if players have a handicap.



### **After booking on-line, do I have to report to the Pro Shop?**

Yes you do. Always



**Will I have a membership bag tag?**

No but you must have your membership card and a valid ticket when playing golf.



**Can I sign in a guest; is there a limit to the number of times?**

No you cannot but you can use your points for guests.



**Can I be signed in as a member's guest?**

No you cannot.



**What do I do if I run out of points?**

You can rejoin for the same price. Your points are valid for one year from the date of joining but if used up before then you can certainly buy in again.



**Will my access to the club website be restricted?**

You will have full use of the club website, booking system and electronic newsletters while you are a corporate member of the club.



**Will I be able to attend social events bringing family and friends?**

Yes you certainly will.



**Do all my credits have to be used within 12 months, or can it roll over?**

Points must be used within 12 months of purchase as they cannot be carried over.



**I didn't play at all, can I carry forward all points to the following year**

Sorry no you cannot.



**Can I use my points for a society/group booking ?**

The points cannot be used for large groups but can be used for up to 12 people in the same group, provided they are not part of a larger group/society and subject to

availability. Any groups of 6 or more wishing to play at weekends would be by prior notice and subject to availability.
